- Until a formal response is received from the NPTA, you do not yet have permission to reprint. Please allow at least five (5) working days for processing, as we need time to consider your request and to contact the author of the article you wish to reprint.
- Once approved, the permission granted herein shall terminate if the work is not published within one year following the date of execution of this agreement or if the work remains out of print for at least six months.
